TO A LINE: From Point A running generally NE to Point D (GR 42737 28462) then ESE to Point C (GR 42751 28457), a total distance of approx, 263 metres as shown on the Order plan. The new route shall have a width of 2 metres. DIVERT: That section of M289a commencing on Newhall Green Lane at Point A (GR 42670 28592) running generally E for approx.195 metres, then NE for approx. 300 metres to Point B (GR 42708 28617). TO A LINE: From Point B running W for approx, 60 metres to Point C (GR 42703 28617). then generally SW for approx, 280 metres, passing through Points D and E to join M289 at Point F (GR 42680 28601) as shown on the Order Plan. The new route shall have a width of 2 metres.
