

**ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)
THE A45 TRUNK ROAD (FESTIVAL ISLAND) (TEMPORARY
RESTRICTION AND PROHIBITION OF TRAFFIC) ORDER 2015**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company no. 9346363) has made an order on the A45 Trunk Road, in the County of Warwickshire, to allow bridge expansion joint renewal works to be carried out.

The effect of the Order will be to close part of the circulatory carriageway at the roundabout junction of the A45, A46, A444 and Leaf Lane, known as Festival Island, from its junction with the slip road leading to the southbound carriageway of the A46, to its junction with the slip road leading from the northbound carriageway of the A46;

The work will be carried out over three nights between 21:00 hours and 06:00 hours and is expected to start on Tuesday 5 January 2016. The order will come into force on Tuesday 29 December 2015.

Vehicles being used for police, fire brigade or ambulance purposes and vehicles being used in connection with the works will be exempt from the closures.

A Diversion route via the A46 will be signed.

THE A45 TRUNK ROAD (STONEBRIDGE) (TEMPORARY PROHIBITION
OF TRAFFIC) ORDER 2015**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company no. 9346363) has made an order on the A45 Trunk Road, in the County of Warwickshire and the Metropolitan Borough of Solihull, to allow implementation of traffic signals, kerb and footway realignment, surfacing, and road marking works to be carried out.

The effect of the Order will be, in phases, to close –

- (a) various lengths of the circulatory carriageway of the roundabout junction of the A45 and the A452 at Stonebridge (Stonebridge Roundabout);
- (b) the slip road leading from the eastbound carriageway of the A45 to Stonebridge Roundabout;
- (c) the slip road leading from the westbound carriageway of the A45 to Stonebridge Roundabout;
- (d) close the gap in the central reservation of the A452, adjacent to Diddington Lane;
- (e) close the laybys located-
 - i) adjacent to the slip road leading from the eastbound carriageway of the A45 to Stonebridge Roundabout; and
 - ii) adjacent to the slip road leading from the westbound carriageway of the A45 to Stonebridge Roundabout.

The carriageway closures will be in operation overnight from 21:00 hours to 06:00 hours. The works are expected to start on Monday 4 January 2016 and continue for three months. The layby closures will be in operation for 24 hours per day starting at 0.01 on Monday 4 January 2016 and ending at 11.59 on Wednesday 30 March 2016. The Order will come into force on Monday 28 December 2015.

Vehicles being used for police, fire brigade, ambulance purposes and vehicles being used in connection with the works will be exempt from the closures. Diversion routes using alternative junctions of the A45 and the A452 will be signed. Local diversion routes will also be in operation.
