ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF GREEN END ROAD, FILLONGLEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Green End Road, Fillongley, from Meriden Lane to Hardingwood Lane, to vehicular traffic.

Please note – access from and to the following roads may be disrupted whilst the works are in progress:

Pump Lane, Solomon's Temple Lane, Newhall Green Lane, Gorseley Green Lane, Stoney Lane, Musson Hall Farm Lane and Culvers Lane.

The closure is required for carriageway resurfacing.

The Order will commence on 15 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 28 March 2017.

Please note – The work will be carried out between the above dates on week days only.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Meriden Road, Tamworth Road, Station Hill, Tamworth Road, Nuneaton Road, Coleshill Road, Church Road, Coleshill Road, Castle Lane, Coleshill Road, New End Road, Church Lane and vice versa.

TEMPORARY CLOSURE OF NUNEATON ROAD AND MERIDEN ROAD, FILLONGLEY

Warwickshire County Council has made a Temporary Traffic Order closing Nuneaton Road and Meriden Road, Fillongley as indicated in the schedule below to vehicular traffic.

Nuneaton Road	From Church Lane to Tamworth Road	Nuneaton Road, Park Lane, Nuthurst Lane, Ansley Road, Birmingham Road, Nuneaton Road, Tamworth Road, Station Hill, Tamworth Road and vice versa
Meriden Road	From Ousterne Lane to Tamworth Road	B4102 Meriden Road, Fillongley Road, Hampton Lane, A452, A446 Stonebridge Road, Birmingham Road, Blythe Road, Coleshill Road, Church Road, Coleshill Road, Nuneaton Road, Tamworth Road, Station Hill, Tamworth Road and vice versa

The closure is required for to facilitate works for carriageway resurfacing and junction improvements.

The Order will commence on 5 March 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.

Please note: The roads will be closed each Sunday commencing 5 March 2017 with anticipation of completion on Sunday 26 March 2017

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
