## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF MILL LANE, FILLONGLEY**

Warwickshire County Council has made a Temporary Traffic Order closing Mill Lane, Fillongley to vehicular traffic.

The closure is required to facilitate works for the laying of a duct.

The Order will commence on 16 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 18 October 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Mill Lane, Tamworth Road, Station Hill, Daw Mill Lane, Newtown Lane, Tower Lane, Shawbury Lane (and vice versa).

## **TEMPORARY CLOSURE OF STONEY LANE, FILLONGLEY**

Warwickshire County Council has made a Temporary Traffic Order closing Stoney Lane, Fillongley from the junction with Green Lane for a distance of approximately 200 metres in a south westerly direction, to vehicular traffic.

The closure is required to safely facilitate overhead cabling works.

The Order will commence on 16 October 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 20 October 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Gorse Green Lane, Stoney Lane, Green End Road, Newhall Green Lane, Meriden Road, Fillongley Road, Kinwalsey Lane (and vice versa).

## **TEMPORARY CLOSURE OF D1794 BAYTON ROAD ROUNDABOUT & D1796 STEPHENSON ROAD, EXHALL – ROAD CLOSURE**

Warwickshire County Council proposes to make a Temporary Traffic Order closing D1794 Bayton Road Roundabout & D1796 Stephenson Road, Exhall to vehicular traffic.

The closures are required to facilitate works for carriageway resurfacing.

Please note: the works will be carried out nightly between 19:00 - 06:00 hrs.

The Order will commence on 2 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 6 November 2017, weather permitting.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Brindley Road and vice versa.
