## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF BREACH OAK LANE, FILLONGLEY**

Warwickshire County Council has made a Temporary Traffic Order closing Breach Oak Lane, Fillongley from a point outside Beckfield Lodge Farm to the junction of Square Lane, to vehicular traffic.

The closure is required to facilitate works to clear blockages.

The Order will commence on 27 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 29 November 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Breach Oak Lane, Smorrall Lane, Highfield Lane, Tamworth Road, Wood End Lane, Astley Lane (and vice versa).
