ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF THE ROW, ANSTY

Warwickshire County Council has made a Temporary Traffic Order closing The Row, Ansty, from a point outside Rose Cottage, to vehicular traffic.

The closure is required to facilitate works to repair a water pipe.

The Order will commence on 31 October 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 1 November 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF KIRBY LANE, WITHYBROOK

Warwickshire County Council proposes to make a Temporary Traffic Order closing Kirby Lane, Withybrook from a point outside property number 1 to Bow Barn, to vehicular traffic.

The closure is required to facilitate works to locate and move a fire hydrant.

The Order will commence on 15 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 21 December 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Kirby Lane, Bow Lane, Main Street, Rugby Road, Fosse Way and vice versa.

TEMPORARY CLOSURE OF BERRYFIELDS, FILLONGLEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Berryfields, Fillongley to vehicular traffic.

The closure is required to facilitate drainage works.

The Order will commence on 12 November 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 November 2018.

PLEASE NOTE: The work will be carried out between 08.00hrs and 17.00hrs.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4102 Nuneaton Road, Berryfields and vice versa.
