THE A46 TRUNK ROAD (STONELEIGH, WARWICKSHIRE)  
(LINK ROADS) (TEMPORARY PROHIBITION OF TRAFFIC)  
ORDER 2019**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the A46 Trunk Road, at Stoneleigh, in the County of Warwickshire, to allow vegetation maintenance to be carried out.

The effect of the Order will be to close –

- a) the link road leading from the northbound carriageway of the A46, to its junction with Stoneleigh Road at Stoneleigh; and
- b) the link road leading to the southbound carriageway of the A46, from its junction with Stoneleigh Road at Stoneleigh.

The work will be carried out overnight between 21:00 hours and 06:00 hours and is expected to start on Monday 4 March 2019 and continue for four nights. The Order will come into force on 1 March 2019.

Vehicles being used for police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures.

Diversion routes via the A46 Stivichall Interchange will be signed.

(TEMPORARY PROHIBITION OF TRAFFIC IN LAYBY)  
ORDER 2019**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the A46 Trunk Road, at Harvington, in the County of Worcestershire, to enable vegetation maintenance work to be carried out.

The effect of the Order will be to close the layby adjacent to the southbound carriageway of the A46 approximately 703 metres southwest of the centreline of Anchor Lane overbridge, at Harvington.

The work will be carried out between 09:30 hours and 15:00 hours and is expected to start on Wednesday 6 March 2019 and continue for one week. The Order will come into force on 1 March 2019.
