

## **ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C32 BIRMINGHAM ROAD, STONELEIGH**

Warwickshire County Council proposes to make a Temporary Traffic Order closing C32 Birmingham Road, Stoneleigh, from its junction with Hall Close to its junction with Stoneleigh Close, to vehicular traffic.

The closure is required to facilitate kerbing and footway works. It is anticipated that works will be carried out between 09.30hrs and 15.30hrs each day and the road will re-open outside of these hours

The Order will commence on 3 June 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 7 June 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Birmingham Road, B4115 Ashow Road, B4113 St. Martins Road, B4113 Coventry Road, The Bank, Birmingham Road and vice versa.

## **TEMPORARY CLOSURE OF D515 OUSTERNE LANE, FILLONGLEY**

Warwickshire County Council has made a Temporary Traffic Order closing D515 Ousterne Lane, Fillongley, from the junction with B4102 Meriden Road to the junction with B4098 Coventry Road, to vehicular traffic. The closure is required to facilitate works for carriageway alterations.

The Order will commence on 20 May 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 31 May 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## **TEMPORARY CLOSURE OF COMMON LANE, CORLEY MOOR**

Warwickshire County Council has made a Temporary Traffic Order closing Common Lane, Corley Moor, from the junction with Wall Hill Road to the junction with Church Lane, to vehicular traffic. The closure is required for carriageway resurfacing & associated works.

The Order will commence on 21 May 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed 29 May 2019.

**PLEASE NOTE:** The work will be carried out between 08.0hrs and 17.00hrs on week days only.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
