

**ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)
THE A46 TRUNK ROAD (WINTHORPE TO CARHOLME)
(TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the A46 Trunk Road, between Winthorpe and Carholme, in the Counties of Nottinghamshire and Lincolnshire, to allow routine maintenance works to be carried out.

The effect of the Order will be to close, at different times –

- (1) the link road leading to and from the northbound carriageway of the A46, to and from Brough Lane, at Brough;
- (2) any gap in the central reservation of the A46 between its roundabout junction with the A1133, at Winthorpe, and its roundabout junction with the A57, at Carholme; and
- (3) any layby located adjacent to the northbound or southbound carriageways of the length of the A46 described at (2) above.

The work will be carried out overnight between 20:00 hours and 06:00 hours and is expected to start on Thursday 11 July 2019 and continue for eight nights. The layby closures will be in operation for 24 hours per day starting from 13:00 hours on Thursday 11 July 2019 and will continue for the duration of the works. The Order will come into force on 8 July 2019.

Vehicles being used for police, fire and rescue authority or ambulance purposes and vehicles being used in connection with the works will be exempt from the closures and prohibition. Access to properties will be maintained at all times.

Diversion routes via alternative junctions of the A46 will be signed.

THE A46 TRUNK ROAD (FARNDON, NOTTINGHAMSHIRE)
(TEMPORARY RESTRICTION OF TRAFFIC) ORDER 2019**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A46 Trunk Road, at Farndon in the County of Nottinghamshire, because of the likelihood of danger to the public.

The effect of the Order will be to impose, commencing on Monday 8 July 2019, a 40 miles per hour speed limit on –

- 1) the northbound carriageway of the A46 from a point 400 metres south of its roundabout junction with the B6166 and Fosse Road (Farndon Roundabout), to a point 400 metres north of that roundabout;
- 2) the southbound carriageway of the A46 from a point 400 metres north of Farndon Roundabout, to a point 400 metres south of that roundabout; and
- 3) the circulatory carriageway of Farndon Roundabout.

The speed restrictions will be in operation for 24 hours per day. The Order will come into force on Friday 5 July 2019.

Vehicles being used by the emergency services or special forces will be exempt from the speed restrictions.
