THE A46 TRUNK ROAD (BINLEY WOODS,
COVENTRY) (TEMPORARY RESTRICTION
OF TRAFFIC) ORDER 2019

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A46 Trunk Road, at Binley

Woods, in the City of Coventry, to enable survey, improvement and maintenance works to be carried out. The effect of the Order will be to impose a

- 50 miles per hour speed limit on the northbound carriageway of the 1) A46 from a point 1800 metres south of its roundabout junction with the A428, at Binley Woods, to that roundabout junction; and
- 2) the southbound carriageway of the A46 from a point 1500 metres north its roundabout junction with the A428, at Binley Woods, to that roundabout iunction.

The work will be carried out overnight between 22:00 hours and 06:00 hours and is expected to start on Monday 29 July 2019 and continue for one month. The Order will

come into force on Sunday 28 July 2019. Vehicles being used by for police, fire and rescue authority or ambulance purposes or for special forces purposes will be

THE A45 AND A423 TRUNK ROADS (RYTON-ON-DUNSMORE, WARWICKSHIRE) (SLIP ROADS) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019 NOTICE IS HEREBY **GIVEN** that

Highways England Company Limited (Company No. 9346363) has made an Order on the A45 and A423 Trunk Roads, at Ryton on-Dunsmore, in the County of Warwickshire, to allow vegetation and cyclical maintenance works to be carried out.

The effect of the Order will be to close, at different times, the slip roads leading –

- from the eastbound carriageway of the (1) A45 to the roundabout junction with the A423 and Hillman Way, at Ryton on-Dunsmore; from the westbound carriageway of (2)
- the A45 to the roundabout described in (1) above; and to the westbound carriageway of the (3)
- A45 from the roundabout described in (1) above.

The work will be carried out overnight between 21:00 hours and 05:30 hours and is expected to start on Wednesday

July 2019 and continue for three phts. The Order will come into force 31 nights. on 26 July 2019. Vehicles being used by police, fire and rescue authority or ambulance purposes

and vehicles being used in connection with the works will be exempt from the closures Diversion routes via alternative junctions

of the A45 and the A423 will be signed.
