ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF ROWLEY ROAD, BAGINGTON

Warwickshire County Council has made a Temporary Traffic Order closing Rowley Road, Bagington to vehicular traffic. The closure is required for the installation of drainage works.

The Order will commence on 4 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 2 October 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Rowley Road, Coventry Road, Stoneleigh Road, Bubbenhall Road, Chantry Heath Lane, Leamington Road, Oxford Road, Stonebridge Road, A423 J A45 Roundabout, A423 J A45 leave Nw, A45 from J A423 to J A46/B4110 W, London Road, A45 from J A423 to J 445 E, A45 from J A46/B4110 to J A423 E, A45 J A46/B4110 roundabout (and vice versa).

TEMPORARY CLOSURE OF EASTLANG ROAD, FILLONGLEY

Warwickshire County Council has made a Temporary Traffic Order closing Eastlang Road, Fillongley, including its junction with Coventry Road, to vehicular traffic. The closure is required for remedial structural patching of carriageway and associated works. Traffic on the Coventry Road will be managed by two way lights. The Order will commence on 16 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 08.00 and 16.00 on 16 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF OLD HOUSE LANE, CORLEY

Warwickshire County Council proposes to make a Temporary Traffic Order closing Old House Lane, Corley from jct. with Tamworth Road to a point outside Corley Rise, to vehicular traffic. The closure is required for a new gas connection.

The Order will commence on 16 September 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 20 September 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Tamworth Road, Church Lane, Old House Lane (and vice versa).
