## ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a) THE A46 AND A45 TRUNK ROADS (BINLEY WOODS TO TOLLBAR END) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A46 and A45 Trunk Roads, between Binley Woods and Tollbar End, in the City of Coventry and the County of Warwickshire, to allow road markings replacement and maintenance works to be carried out.

The effect of the Order will be to close -

- the westbound carriageway of the A46 from its roundabout junction with the A428, at Binley Woods (Binley Woods Roundabout), to its junction with the A45;
- (2) the westbound carriageway of the A45 from its junction with the A46, to its junction with the entry slip road leading from the roundabout junction with the A46 slip roads, the B4110 and Rowley Road, at Tollbar End (Tollbar End Roundabout);
- (3) the eastbound carriageway of the A45 from its junction with the exit slip road leading to Tollbar End Roundabout, to its junction with the A46;
- (4) the eastbound carriageway of the A46 from its junction with the A45 to its junction with Binley Woods Roundabout;
- (5) the entry slip road leading to the eastbound carriageway of the A46 from Tollbar End Roundabout; and
- (6) any layby adjacent to the lengths of A46 and A45 described in (1), (2), (3) and (4) above. The work will be carried out overnight between 20:00 hours and 06:00 hours and is expected

to start on Monday 16 September 2019 and continue for three weeks. The layby closures will be in operation from 06:00 hours on Monday 16 September 2019 for twenty four hours per day for the duration of the works. The Order will come into force on 9 September 2019. Vehicles being used for police, fire and rescue authority or ambulance purposes and

vehicles being used in connection with the works will be exempt from the closures.

Diversion routes via alternative junctions of the A45 and the A46; via the A428, the A4082 and

the B4110 and vice versa; via the A444, the A4082 and the B4110 and vice versa; via the A445, Westhill Road, Bericote Road, and the A452 and vice versa; and via the B4455, the B4027, the B4082, the A428, the A4082 and the B4110 and vice versa will be signed.

## THE M6 AND M69 MOTORWAYS (HINCKLEY TO ANSTY) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2019

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the M6 Motorway and the M69 Motorway, between Hinckley and Ansty, in the Counties of Leicestershire and Warwickshire to allow carriageway resurfacing, barrier

The effect of the Order will be to close at different times -

repairs and other maintenance works to be carried out.

(1) the southbound carriageway of the M69 from its junction with the exit slip road at Junction 1, to its junction with the A46 (M6 Junction 2);

- (2) the northbound carriageway of the M69 from its junction with the A46 (M6 Junction 2), to its junction with the entry slip road at Junction 1;
- (3) the entry slip road leading to the southbound carriageway of the M69 at Junction 1;
- (4) the link road leading from the southbound carriageway of the M6 at Junction 2 to the northbound carriageway of the M69;
- (5) the link road leading from the northbound carriageway of the B4065 to the link road
- described in (4) above; and
  (6) the link road leading from the southbound carriageway of the M69 to the northbound
- (6) the link road leading from the southbound carriageway of the M69 to the northbound carriageway of the M6 at Junction 2, and to its roundabout junction with the A46, the A4600, the B4065 and the slip roads leading to and from the M6 at Junction 2.

The work will be carried out overnight, on weekdays only, between 20:00 hours and 06:00 hours and is expected to start on Monday 16 September 2019 and continue for approximately four weeks. The Order will come into force on 9 September 2019.
