ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF CHURCH LANE, OLD ARLEY

Warwickshire County Council has made a Temporary Traffic Order closing Church Lane, Old Arley from junction with Rectory Road to junction with Fir Tree Lane to vehicular traffic. The closure is required for structural patching of carriageway, fitting of gully & gully pot and associated works, 08.00 - 16.00 daily.
