ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

HIGH STREET, RYTON ON DUNSMORE

Order Effect: Road Closed to vehicular traffic, from a point outside number 70, to vehicular traffic.

Reason for Order: installation of a water pipe.

Order Commences: 31 October 2019 for up to 18 months.

Anticipated Completion Date: 5 November 2019.

Access & Diversion: High Street, Leamington Road, London Road, A45 From J 445 to J A423 W, A45 From J A423 to J 445 E, Oxford Road, A423 J A45 join Nw, A423 J A45 join including two-way section Se, A423 J A45 roundabout, Stonebridge Road and vice versa.

VICARAGE LANE, ASH GREEN LANE, NEW ROAD & ROYAL OAK LANE, EXHALL

Order Effect: Roads Closed to vehicular traffic at their junction (the crossroads).

Reason for Order: carriageway resurfacing and associated works, 9.30 - 15.30 daily.

Order Commences: 28 October 2019 for up to 18 months.

Anticipated Completion: 29 October 2019.

Access & Diversion: Smorrall Lane, Highfield Lane, Bennetts Road North, Bennetts Road, Bennetts Road South, Keresley Green Road, The Scotchhill, Burnaby Road, Holbrook Lane, Wheelwright Lane, Winding House Lane, A444, Pickards Way, Longford Road, Coventry Road, Black Bank, Coventry Road, Park Road, Newtown Road and Heath Road.

Anticipated Completion: 09 November 2019.
