

**ROAD TRAFFIC REGULATION ACT 1984 -
SECTION 14(1)(a)
THE A45 AND A46 TRUNK ROADS
(STIVICHALL INTERCHANGE)
TEMPORARY PROHIBITION OF TRAFFIC)
ORDER 2020**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the A45 and A46 Trunk Roads, at Stivichall, in the City of Coventry and the County of Warwickshire, to allow carriageway resurfacing works to be carried out.

The effect of the Order will be to, at different times, –

- 1) close -
 - (a) lengths of the circulatory carriageway of the roundabout junction of Leaf Lane, the A45 slip roads, the A46 slip roads and the A444 slip roads, at Stivichall (Stivichall Interchange);
 - (b) the eastbound carriageway of the A45 from its junction with the exit slip road leading to Stivichall Interchange, to its junction with the entry slip road leading from Stivichall Interchange;
 - (c) the westbound carriageway of the A45 from its junction with the exit slip road leading to Stivichall Interchange, to its junction with the entry slip road leading from Stivichall Interchange;
 - (d) the slip road leading to the eastbound carriageway of the A45, from Stivichall Interchange;
 - (e) the slip road leading from the westbound carriageway of the A45, to Stivichall Interchange;
 - (f) the entry slip road leading to the southbound carriageway of the A46 from Stivichall Interchange;
 - (g) the exit slip road leading from the northbound carriageway of the A46 to Stivichall Interchange; and
- 2) prohibit -
 - (a) any vehicle leaving Stivichall Interchange at its junction with the entry slip road leading to the northbound carriageway of the A444;
 - (b) any vehicle entering Stivichall Interchange at its junction with the exit slip road leading from the southbound carriageway of the A444;
 - (c) any vehicle leaving Stivichall Interchange at its junction with the entry slip road leading to the westbound carriageway of the A45;
 - (d) any vehicle entering Stivichall Interchange at its junction with the exit slip road leading from the eastbound carriageway of the A45; and
 - (e) any vehicle from entering or leaving Stivichall Interchange at its junction with Leaf Lane.

The work will be carried out overnight between 20:00 hours and 06:00 hours and is expected to start on Saturday 25 July 2020 and continue for approximately four weeks. The Order will come into force on 24 July 2020.

Vehicles being used for police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works will be exempt from the closures and prohibitions.

Diversion routes via Leaf Lane, Baginton Road, Fenside Avenue, the A444, the A45 and the A46 and via Stivichall Interchange will be signed.
