## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### DEANS WAY, EXHALL

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To enable works to rectify a defect.

**Order Commences:** 15 February 2021 for up to 18 months.

**Anticipated Completion:** 17 February 2021.

**Access & Diversion:** Deans Way, Canon Drive, St Giles Road, Vicarage Lane and vice versa.

### FRIARS CLOSE, BINLEY WOODS

**Order Effect:** Road closed to vehicular traffic between the junctions of Coombe Drive to the end of the cul-de-sac.

**Reason for Order:** Carriageway patching and associated works, 08.00hrs-16.00hrs.

**Order Commences:** 25 August 2020 for up to 18 months. Unfortunately, the works were unavoidably delayed but have now been **rescheduled to 17 February 2021.**

**Anticipated Completion:** In one day on 17 February 2021.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

### GRANT ROAD, EXHALL

**Order Effect:** Road Closure, outside/near to properties number 92-94., to vehicular traffic.

**Reason for Order:** To enable works for the installation of cabling across the carriageway.

**Order Commences:** 1 March 2021 for up to 18 months.

**Anticipated Completion:** 4 March 2021.

**Access & Diversion:** Grant Road, Armson Road and vice versa.

### SHAWBURY LANE, FILLONGLEY

**Order Effect:** Road closed to vehicular traffic from a point outside property known as Four Winds.

**Reason for Order:** To safely enable works for the replacement of a BT pole.

**Order Commences:** 1 March 2021 for up to 18 months.

**Anticipated Completion:** 1 March 2021.

**Access & Diversion:** Shawbury Lane, Tower Lane, Newtown Lane and vice versa.
