

**ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a)
THE A45 TRUNK ROAD (RYTON-ON-DUNSMORE,
WARWICKSHIRE) (SLIP ROAD) (TEMPORARY PROHIBITION
OF TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A45 Trunk Road, at Ryton-on-Dunsmore, in the County of Warwickshire, to allow street lighting and sign installation works to be carried out.

The effect of the Order will be to close a length of the exit slip road leading from the eastbound carriageway of the A45 London Road, to its roundabout junction with the A423 Oxford Road and Hillman Way, at Ryton-on-Dunsmore, from its junction with the eastbound carriageway of the A45, to its junction with the exit slip road leading from the westbound carriageway of the A45.

The work will be carried out over one night between 21:30 hours and 06:00 hours and is expected to start on Monday 22 March 2021. The Order will come into force on 15 March 2021.

Vehicles being used by police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closure.

A diversion route via the A45/Warwick Road/Leamington Road roundabout junction will be signed.

(SLIP ROADS) (TEMPORARY PROHIBITION OF TRAFFIC)
ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the M6 Motorway, in the County of Warwickshire, to enable speed camera maintenance works to be carried out.

The effect of the Order will be to close the slip roads leading to and from the northbound carriageway of the M6, to and from Corley Motorway Services Area, north of Junction 3.

The work is expected to be carried out over one night between 21:00 hours and 06:00 hours and is expected to start on Wednesday 24 March 2021. The Order will come into force on 17 March 2021.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures.
