## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### SOMERS ROAD, BEAUMONT ROAD & CHARITY ROAD (RATHBONE CLOSE), KERESLEY

**Order Effect:** Roads closed to vehicular traffic between the junctions of Hill Road, Exhall Road, Charity Road, junction of Somers Road/Charity Road.

**Reason for Order:** To enable drainage works.

**Order Commences:** 6 April 2021 for up to 18 months.

**Anticipated Completion:** 29 April 2021.

**Access & Diversion:** will be appropriately signed. Access to and egress from Cross Road and The Crescent may be affected while works are in progress.

### BURROW HILL LANE, CORLEY

**Order Effect:** Road closed to vehicular traffic between its junction with Bennetts Road North and Rock Lane.

**Anticipated Completion:** 18 May 2021.
