

**ROAD TRAFFIC REGULATION ACT 1984 -  
SECTION 14(1)(a)  
THE A46 TRUNK ROAD  
(STIVICHALL TO KENILWORTH)  
(TEMPORARY RESTRICTION AND PROHIBITION  
OF TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the A46 Trunk Road between Stivichall and Kenilworth in the City of Coventry and the County of Warwickshire, to allow junction improvement works including preconstruction surveying, resurfacing, bridge, lighting, drainage and maintenance works to be carried out.

The effect of the Order will be to, at different times: –

- (1) impose a 50 miles per hour speed restriction on –
  - (a) the northbound carriageway of the A46 from a point 850 metres southwest of the centreline of Crewe Lane underbridge, at Kenilworth, to a point 150 metres southwest of the centreline of St Martins Road underbridge; and
  - (b) the southbound carriageway of the A46 from a point 500 metres northeast of the centreline of St Martins Road underbridge, to a point 350 metres southwest of the centreline of Stoneleigh Road overbridge, at Stoneleigh;
- (2) close –
  - (a) the northbound carriageway of the A46 from its junction with the exit slip road leading to its roundabout junction with the A452 Leamington Road at Kenilworth (Kenilworth Roundabout), to its junction with the entry slip road leading from its roundabout junction with the A45 slip roads, the A444 slip roads and Leaf Lane, at Stivichall (Stivichall Interchange);
  - (b) the southbound carriageway of the A46 from its junction with the exit slip road leading to Stivichall Interchange, to its junction with the entry slip road leading from Kenilworth Roundabout;
  - (c) any slip road or link road leading to or from the lengths of the A46 described in (2)(a) and (b) above; and
  - (d) any layby adjacent to the lengths of the A46 described in (2)(a) and (b) above; and
- (3) prohibit any vehicle with a width exceeding 2.00 metres from entering or proceeding on –
  - (a) lane three of the northbound carriageway of the A46 from a point 200 metres southwest of the centreline of Crewe Lane underbridge, at Kenilworth, to a point 300 metres southwest of the centreline of St Martins Road underbridge; and
  - (b) lane three of the southbound carriageway of the A46 from a point 100 metres southwest of the centreline of St Martins Road underbridge, to a point 300 metres southwest of the centreline of Stoneleigh Road overbridge, at Stoneleigh.

The work is expected to start on Tuesday 13 April 2021 and continue for approximately sixteen months. The closures will be carried out overnight between 21:00 hours and 06:00 hours. There will be various full weekend closures from 20:00 hours on Friday to 05:30 hours on Monday. The layby closures, speed restrictions and width restrictions will be in operation from 00:01 hours on Tuesday 1 June 2021, for twenty four hours per day, for the duration of the works. The Order will come into force on 6 April 2021.

Vehicles being used for police, fire and rescue authority or ambulance purposes will be exempt from the speed restrictions, width restrictions and closures. Vehicles being used for special forces purposes will be exempt from the speed restrictions. Vehicles being used in connection with the works will be exempt from the closures. Access to properties will be maintained at all times.

Diversion routes using the A45, the A429, the A452, the B4103, Leamington Road, the B4115, the B4113 and alternative junctions of the A46 will be signed.

RYTON-ON-DUNSMORE, WARWICKSHIRE)  
(TEMPORARY PROHIBITION OF TRAFFIC)  
ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an Order on the A45 Trunk Road, from Tollbar End to Ryton-on-Dunsmore, in the County of Warwickshire, to allow resurfacing, drainage and vegetation clearance works to be carried out.

The effect of the Order will be to –

- (1) close the eastbound carriageway of the A45 from its roundabout junction with the B4110, Rowley Road

and the slip roads leading to and from the A46, at Tollbar End, to its roundabout junction with the A445 and Warwick Road, at Ryton-on-Dunsmore; and  
(2) prohibit any vehicle from entering or leaving the eastbound carriageway of the A45 at its junctions with Church Road and Trinity Close, at Ryton-on-Dunsmore.

The work will be carried out overnight between 22:00 hours and 05:00 hours and is expected to start on Monday 26 April 2021 and continue for approximately five nights. The Order will come into force on 19 April 2021.

Vehicles being used for police, fire and rescue authority or ambulance purposes and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the closures and prohibition. Access to properties will be maintained at all times.

A diversion route via the A46, the A452, Bericote Road, Westhill Road and the A445 will be signed.

(TEMPORARY PROHIBITION OF TRAFFIC)  
ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an Order on the A45 Trunk Road, at Ryton-on-Dunsmore in the County of Warwickshire, to allow work to be carried out to improve visibility at the junction with Church Road.

The effect of the Order will be to prohibit vehicles from turning right from the westbound carriageway of the A45 through the gap in the central reservation into Church Road at Ryton-on-Dunsmore.

The work will be carried out during the day between 09:00 hours and 18:00 hours and is expected to start on Tuesday 6 April 2021 and continue for ten days. The Order will come into force on 5 April 2021.

Vehicles being used by police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works or for winter maintenance purposes will be exempt from the prohibition.

A diversion route via an alternative junction of the A45 will be signed.

THE A46 TRUNK ROAD (STIVICHALL INTERCHANGE)  
(SLIP ROAD) TEMPORARY PROHIBITION OF  
TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the A46 Trunk Road, near Stivichall, in the City of Coventry and the County of Warwickshire, to allow street lighting and sign installation works to be carried out.

The effect of the Order will be to close the slip road leading to the southbound carriageway of the A46 from its roundabout junction with Leaf Lane, the A45 slip roads, the A46 slip roads and the A444 slip roads, near Stivichall.

The work will be carried out, overnight between 22:00 hours and 06:00 hours and is expected to start on Wednesday 28 April 2021 and continue for two nights. The Order will come into force on 21 April 2021.

Vehicles being used for police, fire and rescue authority or ambulance purposes, and vehicles being used in connection with the works will be exempt from the closure.

A diversion route via the A444 will be signed.
