THE A45 TRUNK ROAD (RYTON-ON-DUNSMORE TO TOLLBAR END, WARWICKSHIRE) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an Order on the A45 Trunk Road, from Ryton-on-Dunsmore to Tollbar End, in the County of Warwickshire, to allow inspection works to be carried out.

The effect of the Order will be to close the westbound carriageway of the A45 from its roundabout junction with the A445 Leamington Road and Wolston Lane, at Ryton-on-Dunsmore, to its junction with the entry slip road leading from its roundabout junction with the A423 Oxford Road, near Tollbar End.

The work will be carried out overnight between 21:00 hours and 05:00 hours and is expected to start on Monday 17 May 2021 and continue for approximately one week. The Order will come into force on 10 May 2021.

Vehicles being used for police, fire and rescue authority or ambulance purposes and vehicles being used in connection with the works will be exempt from the closure. Access to properties

will be maintained at all times.

ROAD TRAFFIC REGULATION ACT 1984 - SECTION 14(1)(a) THE A45 AND A46 TRUNK ROADS (STIVICHALL INTERCHANGE) TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2021

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the A45 and A46 Trunk Roads, near Stivichall, in the City of Coventry and the County of Warwickshire, to allow bridge replacement, inspections and routine maintenance works to be carried out.

The effect of the Order will be to close -

- (a) a length of the circulatory carriageway of the roundabout junction of the A45 slip roads, the A46 slip roads, the A444 slip roads and Leaf Lane, known as Stivichall Interchange, near Stivichall, from its junction with the slip road leading to the southbound carriageway of the A46, to its junction with the slip road leading to the westbound carriageway of the A45; and
 (b) the exit slip road leading from the northbound carriageway of
- the A46 to Stivichall Interchange.

 The work will be carried out, in phases, and is expected to start on Friday 23 April 2021 and continue for approximately five months.

There will be full weekend closures between -

20:00 hours on Friday 23rd April 2021 and 05:00 hours on Monday 26th April 2021;

20:00 hours on Friday 30th April 2021 and 05:00 hours on Monday 3rd May 2021; and 20:00 hours on Friday 10th September 2021 and 05:00 ho

20:00 hours on Friday 10th September 2021 and 05:00 hours on Monday 13 September 2021.

There will also be an overnight closure, expected to be between the hours of 20:00 hours and 06:00 starting on Sunday 11 July 2021. Due to the nature of the work these dates are subject to weather conditions and may change if necessary.

The Order will come into force on 16 April 2021.
