

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

AVONDALE ROAD, BRANDON

Order Effect: Road closed to vehicular traffic between Main Street and Rugby Road. The One-way traffic flow on Avondale Road will be temporarily suspended to allow access/egress to emergency vehicles, residents and businesses.

Reason for Order: To enable works for a new foul water connection.

Order Commences: 14 June 2021 for 18 months

Anticipated Completion: 25 June 2021.

Access & Diversion: Station Road, Main Street, Brandon Lane, A45 from J A46/B4110 to J A423 E, London Road, A423 J A45 Join including two way section Se, Oxford Road, A423 J A45 roundabout, Hillman Way, A423 J A45 leave Nw, A45 from J A423 to J A46/B4110 W, A45 from J A423 to J 445 E, A45 J A46/B4110 roundabout, Rowley Road, A45 from J A46/B4110 to J A46/A444 W, Stonebridge Highway, Coventry Eastern Bypass, A46 from J A45/B4110 to J A428 Ne, A46 from J A428 to J A45/b4110 Sw, Rugby Road and vice versa.

B4113 ST. MARTINS ROAD, STONELEIGH

Order Effect: Road closed to vehicular traffic from a point o/s Severn Trent Water (Gate 3) to County Boundary, in addition a 10mph speed restriction will be imposed for safety of road users and contractors should access be required.

Reason for Order: To safely enable carriageway surface dressing and associated works, 07.00hrs-19.00hrs.

Order Commences: 25 June 2021 for up to 18 months.

Anticipated Completion: It is anticipated that all works will be completed on or before 30 September 2021. It is anticipated that each road will be closed for no more than six individual days during this period.

Access & Diversion: St Martins Road, A45, A423, A445, Westhill Road, Stoneleigh Road, Stoneleigh Hill, Coventry Road, St Martins Road and vice versa.

MILL LANE, FILLONGLEY

Order Effect: Road closed to vehicular traffic between the junctions of Black Hall Lane and Tamworth Road.

Reason for Order: To enable works for drainage system investigation and cleaning, 08.00hrs-17.00hrs weekdays only.

Order Commences: 21 June 2021 for up to 18 months.

Anticipated Completion: 2 July 2021.

Access & Diversion: Black Hall Lane, Tamworth Road and vice versa.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
