THE M6 MOTORWAY (CORLEY
SERVICES, WARWICKSHIRE) (SLIP
ROAD) (TEMPORARY PROHIBITION OF
TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) intends to make an order on the M6 Motorway, in the County of Warwickshire, to enable street lighting and sign installation works to be carried out.

The effect of the Order will be to close the slip road leading from the southbound carriageway of the M6, to Corley Motorway Service Area.

The work will be carried out overnight between 21:30 hours and 06:00 hours and is expected to start on Monday 12 July 2021 and continue for two nights. The Order will come into force on 9 July 2021.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, and vehicles being used in connection with the works will be exempt from the closure.

(SLIP ROADS) (TEMPORARY
PROHIBITION OF TRAFFIC) ORDER 2021**

NOTICE IS HEREBY GIVEN that Highways England Company Limited (Company No. 9346363) has made an order on the M6 Motorway, in the County of Warwickshire, to enable resurfacing, road markings and signal loop installation works to be carried out to the roundabout at Junction 3.

The effect of the Order will be to close any slip road leading to or from the M6 at Junction 3.

The work is expected to be carried out overnight on weekends only, between 20:00 hours and 06:00 hours, and is expected to start on Friday 2 July 2021 and continue for approximately twelve weeks. The Order will come into force on 25 June 2021.

Vehicles being used for police, fire and rescue authority, ambulance or traffic officer purposes, and vehicles being used in connection with the works will be exempt from the closures.

Diversions routes via alternative junctions of the M6 and via the A444/A5/A453/ A446, and A444/A429/A452/A446 will be signed.
