

## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### MAIN STREET, WITHYBROOK

**Order Effect:** Road closed to vehicular traffic.

**Reason for Order:** To enable utility works.

**Order Commences:** 11 August 2021 for up to 18 months.

**Anticipated Completion:** 16 August 2021.

**Access & Diversion:** Main Street, Rugby Road, Fosse Way, Lutterworth Road, The Crescent, Coventry Road, Shilton Road, Ansty Road, Ansty Lane, Brinklow Road, Leicester Road, Withybrook Road and vice versa.

### STONELEIGH ROAD, STONELEIGH

**Order Effect:** Vehicular traffic will be prohibited from turning Right onto the A46 Northbound slip road.
