## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **B4098 TAMWORTH ROAD, CORLEY**

**Order Effect:** Road closed to vehicular traffic between the junctions of Highfield Lane and Fivefield Road.
