ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

CHURCH LANE, FILLONGLEY

Order Effect: Road closed to vehicular traffic between points outside Bourne Brook and Hill Top.

Reason for Order: To enable works for unlooping electricity supply and installing new service cable.

Order Commences: 7 February 2022 for up to 18 months.

Anticipated Completion: 14 February 2022.

Access & Diversion: Church Lane, Nuneaton Road, Coventry Road, Holbeche Crescent and vice versa.

EXHALL GREEN, EXHALL

Order Effect: Road closed to vehicular traffic.

Reason for Order: To enable works for the repair/replacement of a defective manhole frame and cover.

Order Commences: 4 February 2022 for up to 18 months.

Anticipated Completion: 4 February 2022.

Access & Diversion: Exhall Green, School Lane, Bayton Road, Coventry Road, Hayes Lane, Windmill Road and vice versa.

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

B4029 BRINKLOW ROAD, ANSTY

Order Effect: A 30 mph speed restriction will be imposed on B4029 Brinklow Road from its junction with B4065 and for a distance of 200 metres in a south easterly direction.

Reason for Order: For the safety of all road users and of the contractors working on or near to the highways installing traffic signals and associated works.

Order Commences: 21 February 2022 for up to 18 months.

Anticipated Completion: 10 July 2022.

BRINKLOW ROAD, BINLEY WOODS

Order Effect: A 30mph speed limit will be imposed on Brinklow Road from the bypass bridge to the opening of Beechwood Oak Farm Nursery.

Reason for Order: For the safety of all road users and of the contractors working in the carriageway.

Order Commences: 22 February 2022 for up to 18 months.

Anticipated Completion: 25 February 2022.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
