

ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1)(a) THE M69 MOTORWAY AND A46 TRUNK ROAD (ANSTY TO BINLEY) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2022

NOTICE IS HEREBY GIVEN that National Highways Limited (Company No. 9346363) intends to make an Order on the M69 Motorway and the A46 Trunk Road, in the City of Coventry and the County of Warwickshire, to allow lighting replacement works to be carried out thereon.

The effect of the Order will be to close, at different times –

- (1) the southbound carriageway of the M69 from its junction with the link road leading to the M6 (M6 Junction 2) and to the roundabout junction with the A4600, the B4065 and the M6 slip roads at Junction 2, to its junction with the A46, at Binley;
- (2) the southbound carriageway of the A46 from its junction with the M69, to its roundabout junction with the B4082, at Binley; and
 (3) the link road leading from the junction of the A46 and Central Boulevard, at

of the A46 and Central Boulevard, at Ansty, to the southbound carriageway of the A46.

The work will be carried out overnight between 20:00 hours and 06:00 hours and is expected to start on Monday 7 March

2022 and continue for approximately four weeks. The Order will come into force on 28 February 2022.
