## ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

### **BIRMINGHAM ROAD, STONELEIGH**

**Order Effect:** All traffic will be prohibited from turning right from Birmingham Road onto B4115 Ashow Road.

**Reason for Order:** For the safety of all road users and of the contractors working on or near to the carriageway.

**Order Commences:** 14 March 2022 for up to 18 months.

**Anticipated Completion:** 11 September 2022.

**Access & Diversion:** Stoneleigh Road, Dalehouse Lane, A46 From J A45/A444 to J A452 Sw, Warwick Bypass, A46 from J A452 to J A45/A444 Ne, Ashow Road.

### **D465 DEVITTS GREEN LANE, DEVITTS GREEN**

**Order Effect:** Road closed to vehicular traffic between T Junction of Devitts Green Lane and Wood Lane.

**Reason for Order:** Drainage works, 09:30hrs-15:30hrs.

**Order Commences:** 11 March 2022 for up to 18 months.

**Anticipated Completion:** 11 March 2022.

**Access & Diversion:** Devitts Green Lane, Station Road, Rectory Road, Oak Avenue, Woodside and vice versa.

### **PUMP LANE, SHAWBURY**

**Order Effect:** Road closed to vehicular traffic from a point outside property number 11.

**Reason for Order:** To safely enable works on underground structure.

## HIGHWAYS ACT 1980, SECTION 90A

### **ASH GREEN LANE, ROYAL OAK LANE, NEW ROAD & VICARAGE LANE, ASH GREEN – PROPOSED INSTALLATION OF SPEED CUSHIONS**

Warwickshire County Council proposes, under section 90A of the Highways Act 1980, to install 23 no. speed cushions on the lengths of road described in more detail in the Schedule below.

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 2 – located centrally between property numbers 145a/147 on Royal Oak Lane

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 3 – located outside property number 144 on Royal Oak Lane

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 4 – located outside property number 6 on Ash Green Lane

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 5 – located outside property number 4 on New Road

3 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 6 – located centrally between property numbers 7 & 9 on New Road

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 7 – Vicarage Lane – located 31 metres east of its junction with Ash Green Lane

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 8 – located outside property number 149 on Vicarage Lane

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 9 – located outside property number 34 on Ash Green Lane

2 x Speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 10 – located centrally between property numbers 85 & 87 on Ash Green Lane

2 x Speed cushions 3.7m in length x 1.7m in width x 75mm in height.

Site Location 11 – located centrally between properties numbers 60 & 62 on Ash Green Lane

2 x speed cushions 3.7m in length x 1.7m in width x 75mm in height.
