## ROAD TRAFFIC REGULATION ACT 1984

**Warwickshire County Council has made the following Temporary Traffic Orders:**

### **TEMPLE HILL & LUTTERWORTH ROAD, WOLVEY**

**Order Effect:** Road closed to vehicular traffic between the junctions of Lutterworth Road and Temple Hill.

**Reason for Order:** Utility Diversion across carriageway to safely enable construction of the Temple Hill Roundabout.

**Order Commences:** 18 February 2023 for up to 18 months.

**Anticipated Completion:** 26 February 2023.

**Access & Diversion:** Temple Hill – Temple Hill, Church Hill, The Square, Coventry Road, Withybrook Road, Shilton Lane, Rugby Road, New Street, Nuneaton Road, Bulkington Lane, Lutterworth Road and vice versa.

**Lutterworth Road** – Hinckley Road, A5, The Long Shoot, Eastboro Way, Garrett Street, Highfield Road, Lutterworth Road and vice versa.
