ORDER 2023 NOTICE IS HEREBY GIVEN that National Highways Limited (Company No. 9346363) intends to make an order on the A46 Trunk Road, at Kenilworth, in the County of Warwickshire, to allow telecommunications

works to be carried out. The effect of the Order will be to close the layby adjacent to the northbound carriageway of the A46 approximately 915 metres northeast of the roundabout junction with the A452 Leamington Road, at Kenilworth.

The layby is expected to be closed from 14:00 hours on Monday 6 November 2023 for approximately four days/nights. The Order will come into force on 30 October 2023.

NOTICE IS HEREBY GIVEN that National Highways Limited (Company No. 9346363) intends to make an order on the A46 Trunk Road, at Ansty, in the City of Coventry and the Country of Warwickshire, to allow resurfacing and traffic signal installation works to be carried out.

The effect of the Order will be to close

- (1) the southeastern section of the circulatory carriageway of the roundabout junction of the A46 the B4065, Hinckley Road and the M6 Junction 2 slip roads (Ansty Interchange), from its junction with the southbound carriageway of the A46, to its junction with the northbound
- carriageway of Hinckley Road; the slip road leading from the (2)northbound carriageway of the A46 to Ansty Interchange; and
- (3)the westbound carriageway of Central Boulevard from its diverge with the link road leading to the southbound carriageway of the A46, to its junction

with the slip road described in (2) above. The work will be carried out overnight between 20:00 hours and 06:00 hours and is expected to start on Monday

30 October 2023 and continue for five nights 2023. The Order will come into force on 23 October 2023. Vehicles being used for police, fire and rescue authority or ambulance purpose and vehicles being used in connection

with the works or for winter maintenance purposes will be exempt from the closures Diversion routes via the A4082, Ansty Road and Hinckley Road will be signed.
