Warwickshire County Council has made the following Temporary Traffic Orders:

D3183 EASTFIELD PLACE, RUGBY

Order Effect: Road closed in its entirety from its junction with Little Church Street.

Reason for Order: Carriageway patching, drainage and road markings works, closed 09.30hrs-15.00hrs.

Order Commences: 25 October 2023 for up to 18 months.

Anticipated Completion: 25 October 2023.

Order Effect: Road closed between its junctions with Avenue Road and Edward Street.

Reason for Order: Carriageway patching works, closed 08.00hrs-16.00hrs.

Anticipated Completion: 25 October 2023.

Access & Diversion: Edward Street, Oliver Street, Lawford Road, Victoria Street, Avenue Street and vice versa.

D31080 MILL ROAD & D32160 MURRAY ROAD, RUGBY

Order Effect: Roads closed to vehicular traffic between the junctions of Craven Road and the entrance to Railway Station Car Park.

Reason for Order: Clean gullies and drainage system and associated works, 09.30hrs-15.30hrs. In addition, the weight restriction on Boughton Road, Rugby between its junctions with Mill Road and the A426 will be temporarily suspended to enable the diversion route.

Order Commences: 27 October 2023 for up to 18 months.

Anticipated Completion: 28 October 2023.

Access & Diversion: Mill Road, Boughton Road, A426, A428, Whitehall Road, Murray Road and vice versa.

Order Effect: Footpath closed to ALL traffic between Grid References SP40181 67566 and SP40194 67412.

Reason for Order: To safely enable the demolition of a bridge and the new ramps levels to be put in place.

Order Commences: 23 October 2023 for up to 6 months.

Access & Diversion: A temporary diversion will be appropriately signed.
