Warwickshire County Council has made the above experimental order under the Road Traffic Regulation Act 1984 ("the 1984 Act"), the effect of which will be to:

1. Prohibit vehicular traffic in Lansdowne Place, Rugby, for its entire length of 143m, between Monday and Friday between the hours of 8:15-9:15am and 2:30-3:30pm during School Term Time (following Warwickshire Term Dates).

The Experimental Order commences on 6th November 2023 and lasts for a period of up to 18 months. The Experimental Order contains exemptions for the emergency services, blue badge holders and permit holders.
