ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

A452 WARWICK ROAD, KENILWORTH

Order Effect: Road between the junctions of St Johns Road and Whites Row.

Reason for Order: To enable drainage works, closed 08.00hrs-17.00hrs, Sundays only. **Unfortunately, these works were delayed but have now been rescheduled as follows:**

12th, 19th & 26th November 2023.

Order Commenced: 4 June 2023 for up to 18 months.

Anticipated Completion: 18 June 2023.

Access & Diversion: A452, A46, A45, A429 and A452.

D6043 MILL STREET, HARBURY

Order Effect: Road closed to vehicular traffic between its junctions with Chapel Street/High Street and Farm Street.

Reason for Order: Carriageway patching and associated works, 08.00hrs-16.00hrs.

Order Commences: 5 November 2023 for up to 18 months.

Anticipated Completion: 5 November 2023.

Access & Diversion: Chapel Street, Park Lane, Farm Street and vice versa. Access/egress to be maintained where possible to businesses and residents only. Access to/egress from Manor Orchard, Heber Drive, Knightlow Way and Wagstaffe Close will be via Farm Street only whilst works are in progress.

Anticipated Completion: 8 November 2023.

Order Effect: Roads closed to vehicular traffic.

Order Commences: 23 November 2023 for 18 months.

Anticipated Completion: 1 December 2023.
