

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

D3241 LOWER HILLMORTON ROAD, C30 THE KENT, C30 SCHOOL STREET, D3310 LOWER STREET, RUGBY

Order Effect: Roads closed to vehicular traffic as follows: **Lower Hillmorton Road** closed between Linnell Road and The Kent, **The Kent** closed between Lower Hill Morton Road and School Street, **School Street** closed between The Kent and School Gardens (inc. Roundabout), and **Lower Street** closed between School Street Roundabout and Fox Close.

Reason for Order: Carriageway resurfacing and associated works, 08.00hrs-17.00hrs weekdays only. **Please Note:** Work will be completed in phases between the dates below.
