

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

PUBLIC FOOTPATHS R117 & R117A, CHURCH LAWFORD, RUGBY

Order Effect: Footpaths closed to ALL traffic as follows: R117/2 from Grid Ref SP45731,75828 to 45739,75912, R117/5 from Grid Ref SP15739,75912 to 45737, 75971 and R117a/1 from Grid Ref SP45739,75912 to 45786,75935.

Reason for Order: For the safety of the public until structural repairs are completed on the railway structure under which the footpaths pass.

Order Commenced: 3 January 2023 and was due to expire 2 January 2023. However, the Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has directed that the Order shall continue in force until 2 July 2024 or until works are completed, whichever is the earlier (unless the Secretary of State issues a further direction).

Warwickshire County Council proposes to make the following Temporary Traffic Orders:

COCK ROBIN ROUNDABOUT, RUGBY ROAD, ASHLAWN ROAD & DUNCHURCH ROAD, RUGBY

Order Effect: A 30 mph Speed Limit will be imposed on the lengths of road as follows:

The entirety of the Cock Robin roundabout, Rugby Road, Dunchurch from Cock Robin roundabout for a distance of 220 metres in a westerly direction, Ashlawn Road from Cock Robin roundabout for a distance of 520 metres in an easterly direction, Dunchurch Road from Cock Robin roundabout for a distance of 150 metres in a northerly direction.

Reason for Order: For the safety of all road users and of the contractors working on the carriageway (alterations to the existing Cock Robin roundabout and approaches thereto).

Order Commences: 8 January 2024 for up to 18 months.

Anticipated Completion: 17 June 2024.

CHURCH STREET, RUGBY

Order Effect: Road closed to vehicular traffic.

Reason for Order: Works in underground structure, closed 22.00hrs-06.00hrs.

Order Commences: 6 January 2024 for up to 18 months.

Anticipated Completion: 7 January 2024.

Access & Diversion: Clifton Road, Whitehall Road, Hillmorton Road, Lawrence Sheriff Street, Dunchurch Road, Russelsheim Way, Bilton Road, Corporation Street, Evreux Way, North Street, Church Street and vice versa.

CALIAS LANE, BIRDINGBURY

Order Effect: Road closed between its junction with Gibraltar Lane.

Reason for Order: Works for pole renewal, closed 09.30hrs-15.30hrs.

Order Commences: 10 January 2024 for up to 18 months.

Anticipated Completion: 10 January 2024

Access & Diversion: Gibraltar Lane, Hospital Lane, Southam Road, Calias Lane and vice versa.

FOSTERD ROAD, RUGBY

Order Effect: Road closed to vehicular traffic.

Reason for Order: To safely enable works for hydrant renewal.

Order Commences: 10 January 2024 for 18 months.

Anticipated Completion: 12 January 2024.

Access & Diversion: Fosterd Road, Yates Avenue and vice versa.

HINCKLEY ROAD, WOLVEY

Order Effect: Road closed to southbound vehicular traffic from its junction with A5 for a distance of 230 metres.

Reason for Order: To enable works for the replacement of a cable and provision of a new service.

Order Commences: 8 January 2024 for up to 18 months.

Anticipated Completion: 11 January 2024.

Access & Diversion: A5, Smockington Lane, Lutterworth Road, Hinckley Road.

For all of the above temporary orders, pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
