TEMPORARY CLOSURE & NO WAITING/NO STOPPING RESTRICTIONS

AT A444 JIMMY HILL WAY, COVENTRY FOR (EVENTS AT COVENTRY

BUILDING SOCIETY ARENA)

Warwickshire County Council has made a Temporary Traffic Order, the effect of which will be to close the A444 Jimmy Hill Way, Coventry, to vehicular traffic, between the County Boundary with Coventry and its roundabout junction with M6 Junction 3, and to impose no waiting and no stopping restrictions thereupon. The temporary restrictions are required in the interests of public safety due to anticipated large crowds exiting events at the nearby Coventry Building Society Arena, and to assist with facilitating safe pedestrian egress therefrom.

The Order commences on 13 January 2024 and ends on 31 July 2024. However, it is anticipated that the temporary restrictions will only be in operation during those times described in the Schedule below.

Pedestrian access will be maintained at all times and exemptions will be applied for the emergency services.

An alternative route will be available via Pickards Way, Longford Road, Coventry Road, School Lane, Church Lane, Vicarage Lane, Ash Green Lane, Wheelwright Lane, Holbrook Lane, Holbrook Way, Jimmy Hill Way and vice versa.
