

ROAD TRAFFIC REGULATION ACT 1984

Warwickshire County Council has made the following Temporary Traffic Orders:

D3241 LOWER HILLMORTON ROAD AND D3279 KINGSLEY AVENUE, RUGBY

Order Effect: Roads closed as follows: **D3241 Lower Hillmorton Road** – between Langton Road and Loverock Crescent.

D3279 Kingsley Avenue – closed between Lower Hillmorton Road and Edgecote Close.

Reason for Order: Carriageway patching works, closed 08.00hrs-17.00hrs.

Order Commences: 24 March 2024 for up to 18 months.

Anticipated Completion: 24 March 2024.

Access & Diversion: Lower Hillmorton Road – Lower Hillmorton Road, The Kent, School Street, Deerings Road, A426, A428, Langton Road and vice versa.

Kingsley Avenue – Access/Egress to be via A428 Hillmorton Road only.

PUBLIC FOOTPATH R168Y, DUNCHURCH

Order Effect: Footpath closed to ALL traffic between point A- Grid References E446578 N271830 and point B- Grid References E446324 N272224.

Reason for Order: Because works are being carried out on or near to the footpath.

Order Commenced: 1 April 2022 for up to 6 months or until the works to which it related were completed whichever was the sooner; following direction from the Secretary of State the Order was extended and was due to expire 29 March 2024.

However, the Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has issued a further direction that the Order shall continue in force until **29 March 2025**, or until works are completed, whichever is the earlier (unless the Secretary of State issues a further direction).
