

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D2330 SCHOOL STREET, STOCKTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing D2330 School Street, Stockton from a point outside the Barley Mow Public House, to vehicular traffic.

The closure is required to facilitate the connection of new water plots.

The Order will commence on 14 March 2016 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 March 2016.

TEMPORARY CLOSURE OF B4551 STATION ROAD, BISHOPS ITCHINGTON
