## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF WINDMILL LANE, LADBROKE

Warwickshire County Council has made a Temporary Traffic Order closing Windmill Lane, Ladbroke from the junction with Southam Road to a point outside the property known as Hillview, to vehicular traffic.

The closure is required to facilitate works for the installation of ducting.

The Order will commence on 20 April 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 24 April 2017.
