

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D2413 RADBOURNE ROAD, LADBROKE

Warwickshire County Council has made a Temporary Traffic Order closing D2413 Radbourne Road, Ladbroke from the junction with A423 to The Willows, to vehicular traffic. The closure is required to facilitate carriageway patching works.

The Order will commence on 29 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 30 August 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF STATION ROAD, FENNY COMPTON

Warwickshire County Council has made a Temporary Traffic Order closing Station Road, Fenny Compton, from a point 20 metres either side of the railway bridge, to vehicular traffic.

The closure is required to safely facilitate repairs to defective bridge masonry.

The Order will commence on 29 August 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 2 September 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

TEMPORARY CLOSURE OF SOUTHAM ROAD, STOCKTON

Warwickshire County Council has made a Temporary Traffic Order closing Southam Road, Stockton, from the A426/A423 Roundabout to a point approximately 550 metres south of the junction with Stockton Road/Napton Road, to vehicular traffic.

The closure is required to facilitate resurfacing and marking of the carriageway.

TEMPORARY CLOSURE OF LADBROKE ROAD, BISHOPS ITCHINGTON

The closure is required to safely facilitate examination of the railway bridge.

TEMPORARY CLOSURE OF NAPTON HOLT ROAD, SOUTHAM
