

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C140 CHURCH ROAD, LADBROKE

Warwickshire County Council has made a Temporary Traffic Order closing C140 Church Road, Ladbroke from the Old Rectory to Lodge House to vehicular traffic.

The closure is required to facilitate works for the installation of drainage in the carriageway.

The Order will commence on 13 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 17 November 2017, weather permitting.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Church Road, Harbury Road, Kineton Road, Leamington Road, A423 Banbury Road, A423 Southam Road, Old Banbury Road, School Lane and vice versa.

TEMPORARY CLOSURE OF B4455 FOSSE WAY, CHESTERTON

Warwickshire County Council has made a Temporary Traffic Order closing B4455 Fosse Way, Chesterton from points approximately 20 metres either side of the bridge, to vehicular traffic.

The closure is required to safely facilitate essential maintenance works including the reinstatement of damaged & missing chevrons and repairs to the concrete arch soffit caused by vehicle incursion.

Details with regard to the dates of the road closure, as advertised in the Leamington/Warwick/Southam Observer week ending 26 October 2017, have been changed.

The Order commences on 13 November 2017 for a period of 18 months, or until the works are completed, whichever is the earlier **however the closure and therefore the work will not commence until 20 November 2017.**

Please Note: The works will be carried out overnight between 22.00hrs and 05.00hrs with anticipation of completion by 05.00hrs on 24 November 2017.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Fosse Way, Harbury Lane, Chesterton Road, Plough Lane, Butt Lane, Bush Heath Road, Ufton Road, Southam Road, Ufton Hill (and vice versa).

TEMPORARY CLOSURE OF D23030 BRICKYARD ROAD, NAPTON ON THE HILL

Warwickshire County Council proposes to make a Temporary Traffic Order closing D23030 Brickyard Road, Napton on the Hill from A425 Southam Road to Poplar Road, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 27 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 29 November 2017.
