## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF HOSPITAL LANE & MAIN STREET, BROADWELL

Warwickshire County Council has made a Temporary Traffic Order closing Hospital Lane & Main Street, Broadwell to vehicular traffic.

Details of the closure and Order as previously advertised in the Southam Observer have been changed and are now scheduled as indicated below.

| Main Street   | From the junction with Hospital Lane to a point opposite Pine Lodge | 27/11/2017 to 30/11/2017 | Main Street, Hayway Lane, Flecknoe Road, Southam Road, Hospital Lane (and vice versa) |

The closures are required to safely facilitate works to install ducts in the verges and carriageways.

The Order commenced on 8 November 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## TEMPORARY CLOSURE OF B4455 FOSSE WAY & WINDMILL HILL LANE, CHESTERTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4455 Fosse Way, Chesterton from the junction at the B4100 roundabout northwards to the junction of Harbury Lane and Windmill Hill Lane, Chesterton at its junction with the Fosse Way, to vehicular traffic.

The closure is required to facilitate carriageway resurfacing works.

The Order will commence on 4 December 2017 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 18 December 2017, weather permitting.

Please note: the works will be carried out overnight between 20.00hrs and 06.00hrs nightly.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Banbury Road, Gaydon Road, Station Road, Deppers Bridge Road, Ufton Road, A425 Southam Road, Fosse Way and vice versa.
