

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF HACKWELL STREET, NAPTON ON THE HILL

Warwickshire County Council proposes to make a Temporary Traffic Order closing Hackwell Street, Napton on the Hill from a point outside the property known as Hill View, to vehicular traffic.

The closure is required to facilitate works for the renewal of a water pipe.

The Order will commence on 13 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 March 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Hackwell Street, School Hill, Poplar Road, Howcombe Lane, New Street, High Street (and vice versa).

## TEMPORARY CLOSURE OF C51 KNIGHTCOTE ROAD & D6396 KNIGHTCOTE BOTTOM, KNIGHTCOTE

Warwickshire County Council proposes to make a Temporary Traffic Order closing C51 Knightcote Road & D6396 Knightcote Bottom, Knightcote from the junction of C51 Knightcote Road and D6396 Knightcote Bottom, to vehicular traffic.

The closure is required to facilitate carriageway patching works.

The Order will commence on 12 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 13 March 2018.

## TEMPORARY CLOSURE OF D2356 SPRINGS CRESCENT, SOUTHAM

## TEMPORARY CLOSURE OF A423 SOUTHAM ROAD/LADBROKE BYPASS/BANBURY ROAD, LADBROKE (TO SOUTH BOUND TRAFFIC)

and

## TEMPORARY 40MPH SPEED RESTRICTION A423 SOUTHAM ROAD/ LADBROKE BYPASS/BANBURY ROAD, LADBROKE

and

## TEMPORARY 10MPH SPEED RESTRICTION (NORTH BOUND TRAFFIC) A423 SOUTHAM ROAD/LADBROKE BYPASS/BANBURY ROAD, LADBROKE

Warwickshire County Council has made a Temporary Traffic Orders closing the A423 Southam Road/Ladbroke Bypass/Banbury Road, Ladbroke from a point 100m North of C140 Banbury Road (north end), Ladbroke to a point 200m South of C140 Banbury Road (south end) to south bound vehicular traffic and restricting the speed of all vehicles as indicated below) on A423 Southam Road/Ladbroke Bypass/Banbury Road, Ladbroke

**THE RESURFACING WORKS ARE BEING CARRIED OUT OVERNIGHT BETWEEN 20.00HRS AND 06.00HRS NIGHTLY AND THE ROAD WILL BE CLOSED TO ALL SOUTHBOUND TRAFFIC.**

**A 10MPH SPEED RESTRICTION WILL APPLY TO NORTHBOUND TRAFFIC OVERNIGHT WHILST THE CONTRACTORS ARE WORKING IN THE CARRIAGEWAY.**

**THE ROAD WILL BE OPEN TO ALL TRAFFIC DURING THE DAY TIME WHEN WORK IS NOT IN PROGRESS AND A 40 MPH SPEED RESTRICTION WILL BE IN FORCE AND APPLIES TO ALL TRAFFIC TRAVELLING IN BOTH A NORTHERLY AND SOUTHERLY DIRECTION.**

The closure is required to facilitate carriageway resurfacing works; the speed restrictions are for the safety of all road users and of the contractors working in the carriageway whilst the road is being resurfaced.

The Orders will commence on 28 February 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 March 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.
