

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF C113 DASSETT ROAD, AVON DASSETT

Warwickshire County Council proposes to make a Temporary Traffic Order closing C113 Dasset Road, Avon Dasset from its junction with Lower End to a point east of the junction with Farnborough Road, to vehicular traffic.

The closure is required to facilitate carriageway resurfacing works.

The Order will commence on 22 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. The work will be carried out daily between 08.00hrs and 17.00hrs however the road will remain completely closed until all work is completed. It is anticipated that works will be completed by 29 March 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Lower End, Church Hill, Avon Dasset Road, Bridge Street, Memorial Road, High Street, Station Road A423 Banbury Road, Ducketts Lane, Main Street, Mollington Lane, Dasset Road and vice versa.

## TEMPORARY CLOSURE OF A425 DAVENTRY ROAD, SOUTHAM & A425 SOUTHAM ROAD, NAPTON ON THE HILL AND TEMPORARY 40MPH SPEED RESTRICTION A425 DAVENTRY ROAD, SOUTHAM & A425 SOUTHAM ROAD, NAPTON ON THE HILL)

Warwickshire County Council has made Temporary Traffic Orders closing A425 Daventry Road, Southam & A425 Southam Road, Napton on the Hill from a point 50 metres east to a point 375 metres west of the junction with Brickyard Lane, to vehicular traffic and restricting the speed of all vehicles on A425 Daventry Road, Southam & A425 Southam Road, Napton on the Hill from the speed limit signs east of Calcutt Meadow to the speed limit signs west of the property known as Westcott House.

The closure is required to facilitate carriageway resurfacing works; the speed restriction is for the safety of all road users whilst the road is being resurfaced.

The Orders will commence on 8 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 March 2018.

Please note: The resurfacing works are being carried out overnight between 20.00hrs and 06.00hrs nightly however the speed restriction will be in force 24 hours a day until completion of the resurfacing works.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: A425 Daventry Road, A423 Southam Bypass, A426 Southam Road, Daventry Road, A45 Daventry Road, A45 London Road, A45 Braunston Road, A45 Leamington Way, A425 Daventry Road, A425 Park Hill, A425 Napton Road, A425 Shuckburgh Road, A425 Southam Road and vice versa.

## THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF WARWICK) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON-STREET PARKING PLACES AND RESIDENTS' PARKING) (VARIATION B) (CONSOLIDATION) ORDER 2018

Warwickshire County Council has made the above named Order pursuant to The Road Traffic Regulation Act 1984, the effect of which is to vary the existing Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places And Residents' Parking) (Consolidation) Order 2017, as described (by approximate measurements) in the Schedule below. The Order commences on Monday 5 March 2018.

Exceptions to any waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the Order, together with a copy of the Order being varied, plans showing the lengths of roads affected and a statement of the Council's reasons for making the Order may be inspected at the Main Reception, Shire Hall, Market Place, Warwick and at Warwick District Council, Riverside House, Milverton Hill, Leamington Spa during usual opening hours.

##### No Waiting At Any Time – Un-named Development Access Road, Kenilworth

- Both sides, from its junction with Common Lane northwards for 60 metres

## TEMPORARY CLOSURE OF GAYDON ROAD, BISHOPS ITCHINGTON

Warwickshire County Council has made a Temporary Traffic Order closing Gaydon Road, Bishops Itchington from the junction of Plough Lane to vehicular traffic.

The closure is required to facilitate the construction of traffic calming measures.

The Order will commence on 4 March 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed in one day on Sunday 4 March 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: B4451 Station Road, B4452 Deppers Bridge Road, B4452 Ufton Road, A425 Southam Road, A425 Ufton Hill, B4455 Fosse Way, B4100 Banbury Road, B4451 Gaydon Road (and vice versa).

## THE WARWICKSHIRE COUNTY COUNCIL (B4451 GAYDON ROAD & STATION ROAD, BISHOPS ITCHINGTON) (30, 40 & 50 MPH SPEED LIMIT) ORDER 2018

Warwickshire County Council have made the above Order under the Road Traffic Regulation Act 1984 the effect of which will be to impose 30, 40 & 50 mph speed limits on the lengths of road mentioned in the Schedules below.

##### 1. B4451 Gaydon Road & Station Road

That length of road from a point 64 metres south west of the boundary between property number 41/43 Gaydon Road in a generally north easterly then north westerly direction to a point 119 metres north west of the junction with Marlow Green (centre of junction)

##### 2. Plough Lane

From its junction with the B4451 Gaydon Road in a north westerly direction to a point 73 metres north west of its junction with Manor Road (centre of junction).

##### 3. Knightcote Road

From its junction with the B4451 Gaydon Road in a generally south easterly direction for a distance of 216 metres.

#### **(40 mph Speed Limit)**

##### 1. B4451 Gaydon Road

That length of road from a point 737 metres south west of its junction with Knightcote Road in a generally north easterly direction to a point 64 metres south west of the property boundary between property number 41/43 Gaydon Road.

##### 2. B4451 Station Road

That length of road from a point 119 metres north of the junction with Marlow Green in a north easterly direction to a point 21 metres north of the boundary between Walworth Farm and the Chapel Cemetery.

##### 1. B4451 Station Road

That length of road from a point 21 metres north of the boundary between Walworth Farm and the Chapel Cemetery to its junction with the B4452/ B4451 Deppers Bridge Road.
