ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF HIGH STREET, BISHOPS ITCHINGTON

Warwickshire County Council has made a Temporary Traffic Order closing High Street, Bishops Itchington from its junction with Fisher Road to a point outside The Laurels, to vehicular traffic.

The closure is required to facilitate utility works.

The Order will commence on 28 June 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 2 July 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: High Street, Fisher Road (and vice versa).

TEMPORARY CLOSURE OF HALL LANE, HARBURY

Warwickshire County Council has made a Temporary Traffic Order closing Hall Lane, Harbury from Crown Street to Dovehouse Lane, to vehicular traffic.

The closure is required to facilitate gas utility works.

The Order will commence on 25 June 2018 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 29 June 2018.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Hall Lane, Crown Street, Vicarage Lane, Bush Heath Road, Ufton Road (and vice versa).

TEMPORARY CLOSURE OF PUBLIC FOOTPATH SM21 IN THE PARISH OF SOUTHAM

Warwickshire County Council has made a Temporary Traffic Order closing Public Footpath SM21 in the Parish of Southam, between Grid Reference SP41397-61743 and SP41281-61727, to all traffic.

The closure is required to avoid the likelihood of danger to the public because works are being or are proposed to be executed on or near to the footpath.

The Order will commence on 25 June 2018 and will last for a period of 6 months, or until the works are completed, whichever is the earlier.

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained where possible.
