## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF WELSH ROAD EAST, SOUTHAM

Warwickshire County Council proposes to make a Temporary Traffic Order closing Welsh Road East, Southam, from a point outside the development site entrance, to vehicular traffic.

The closure is required to facilitate excavation works to enable the installation connection of water pipes to the mains.
