

ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF MAIN STREET, FRANKTON ROAD & BIRDINGBURY ROAD, BIRDINGBURY

Warwickshire County Council has made a Temporary Traffic Order closing Main Street, Frankton Road & Birdingbury Road, Birdingbury, from Leamington Hastings Road to the junction with Bourton Lane, to vehicular traffic.

The closure is required to safely facilitate works for replacement of bridge signage, road marking and associated works.

PLEASE NOTE:

- The works will be carried out between 08.00hrs and 17.00hrs.
- Access to and egress from Draycote Hill may be affected while works are in progress.

The Order will commence on 26 March 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 28 March 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

SOUTH TO NORTH – Leamington Hastings Road, Birdingbury Road, A426 Southam Road, A426 Toft Hill, A426 Southam Road, B4429 Coventry Road, A45 Coventry Road, A45 London Road, B4453 Straight Mile, Main Street, Birdingbury Road, Bourton Lane.

NORTH TO SOUTH – Bourton Lane, Birdingbury Road, Main Street, B4453 Straight Mile, A4071 Blue Boar Flyover, A45 London Road, A45 Coventry Road, B4429 Coventry Road, A426 Southam Road, A426 Toft Hill, A426 Southam Road, Birdingbury Road, Leamington Hastings Road.

TEMPORARY CLOSURE OF SHAKERS LANE, LONG ITCHINGTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Shakers Lane, Long Itchington to vehicular traffic.

The closure is required to facilitate utility works.

The Order will commence on 4 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 8 April 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Shakers Lane, Leamington Road, The Green, Marton Road (and vice versa).
