## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF HOLLY BUSH LANE, PRIORS MARSTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing Holly Bush Lane, Priors Marston to vehicular traffic. The closure is required to facilitate works for a new clean water connection.

The Order will commence on 23 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 25 April 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: The Holloway, The Green, Hellidon Road, Holly Bush Lane (and vice versa).

## TEMPORARY CLOSURE OF B4451 STATION ROAD, BISHOPS ITCHINGTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing B4451 Station Road, Bishops Itchington, from its junction with B4452 Deppers Bridge to its junction with Marlow Green, to vehicular traffic. The closure is required to facilitate works for new carriageway and footway construction.

The Order will commence on 29 April 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 10 June 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access For Residents Only will be managed and maintained.

An alternative route will be signed and is available via: B4452 Deppers Bridge Road, Ufton Road, A425 Ufton Hill, A425 Southam Road, B4455 Fosse Way, B4100 Chesterton Hill, Banbury Road, B4100 Wade Lane, B4451 Gaydon Road, Station Road.
