## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

### TEMPORARY CLOSURE OF D6037 UFTON FIELDS (ALSO KNOWN AS HARBURY LANE), UFTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing D6037 Ufton Fields (also known as Harbury Lane), Ufton, from jct. A425 Southam Road to jct. B4452 Ufton Road, to vehicular traffic. The closure is required for carriageway patching, between 08.00hrs and 16.00hrs daily.

The Order will commence on 15 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: A425 Southam Road, B4452 Ufton Road and vice versa.

### TEMPORARY CLOSURE OF D6396 KNIGHTCOTE BOTTOMS & D6384 HAMBRIDGE ROAD, KNIGHTCOTE

Warwickshire County Council has made a Temporary Traffic Order closing D6396 Knightcote Bottoms, Knightcote, from its junction with the B4451 Gaydon Road to Knightcote Road and D6384 Hambridge Road, Knightcote, from its junction with Knightcote Road to Hambridge Road 'T' junction, to vehicular traffic. The closures are required for carriageway resurfacing and associated works.

The Order will commence on 1 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 19 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

Alternative routes will be signed and are available:

Diversion 1 for Knightcote Bottoms – Knightcote Road, Northend Road, Blacksmith's Lane, Bottom Street, Dasset Road, Village Road, Dasset Road, B4100 Banbury Road, B4451 Gaydon Road and vice versa.

Diversion 2 for Hambridge Road – Hambridge Road, Knightcote Road and vice versa.
