

## ROAD TRAFFIC REGULATION ACT 1984, SECTION 14 TEMPORARY CLOSURE OF D6054 BUSH HEATH LANE, HARBURY

Warwickshire County Council proposes to make a Temporary Traffic Order closing D6054 Bush Heath Lane, Harbury, from its jct. with Park Lane to its jct. with Butt Lane (locally known as Bush Heath Road), to vehicular traffic. The closure is required for carriageway patching.

The Order will commence on 22 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 24 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Butt Lane (Bush Heath Road), Vicarage Lane, South Parade, Park Lane and vice versa.

## TEMPORARY CLOSURE OF B4452 UFTON ROAD, WELSH ROAD & BASCOTE ROAD, UFTON

Warwickshire County Council has made a Temporary Traffic Order closing B4452 Ufton Road, Welsh Road & Bascote Road, Ufton to vehicular traffic as indicated in the Table below.

Bascote Road	Between the junction of A425 Southam Road and the junction of Welsh Road	3 January 2019 To 8 March 2020	Bascote Road, Southam Road, Ufton Hill, Fosse Way, Welsh Road (and vice versa)

The closures are required to facilitate works for the connection of a new power supply for a tunnel boring machine.

The Order will commence on 10 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

## TEMPORARY CLOSURE OF PUBLIC FOOTPATH SM21 IN THE PARISH OF SOUTHAM

Warwickshire County Council made a Temporary Traffic Order closing Public Footpath SM21 in the Parish of Southam, between Grid Reference SP41397-61743 to SP41281-61727, to all traffic. The closure was required to avoid the likelihood of danger to the public because works are being or are proposed to be executed on or near to the footpath.

The Order commenced on 25 June 2018 and was due to expire on 25 June 2019. However, the Secretary of State in exercise of his powers under Section 15(5) of the Road Traffic Regulation Act 1984 has directed that the Order shall continue in force until 25 March 2020 or until the works are completed, whichever is the earlier, (unless the Secretary of state issues a further direction).

Access to and egress from properties and land situated adjacent to the length of footpath to be closed, if any, will be maintained.
