ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

TEMPORARY CLOSURE OF D6039 MIDDLE ROAD, HARBURY

Warwickshire County Council proposes to make a Temporary Traffic Order closing D6039 Middle Road, Harbury, from jct. with B4455 Fosse Way to jct. with Hillside, to vehicular traffic. The closure is required for carriageway patching & associated works.

The Order will commence on 4 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 08.00 and 16.00 on 4 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible.

An alternative route will be signed and is available via: Fosse Way, Harbury Lane, Chesterton Road, Harbury Lane, Temple End, Farm Street, Binswood End, Middle Road and vice versa.

TEMPORARY CLOSURE OF D6384 HAMBRIDGE ROAD, BISHOPS ITCHINGTON

Warwickshire County Council proposes to make a Temporary Traffic Order closing D6384 Hambridge Road, Bishops Itchington, from o/s property number 31 to the T jct. south of Ham Bridge, to vehicular traffic. The closure is required for bridge signing and highway maintenance.

The Order will commence on 1 August 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed between 9.30 and 15.30 on 1 August 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: Hambridge Road, Knightcote Road, Gaydon Road, Chapel Street, Poplar Road, Hambridge Road and vice versa.

TEMPORARY CLOSURE OF D6037 UFTON FIELDS (ALSO KNOWN AS HARBURY LANE), UFTON

Warwickshire County Council has made a Temporary Traffic Order closing D6037 Ufton Fields (also known as Harbury Lane), Ufton, from jct. A425 Southam Road to jct. B4452 Ufton Road, to vehicular traffic. The closure is required for carriageway patching, between 08.00hrs and 16.00hrs daily.

The Order will commence on 15 July 2019 and will last for a period of 18 months, or until the works are completed, whichever is the earlier. However, it is anticipated that the works will be completed by 16 July 2019.

Pedestrian access to and egress from properties and land situated adjacent to the length of road to be closed will be maintained at all times. Vehicular access will be maintained where possible. An alternative route will be signed and is available via: A425 Southam Road, B4452 Ufton Road and vice versa.
